Statement by the board of directors in accordance with Chapter 19 § 22 of the Swedish Companies Act

As regards the authorisation proposed by the board allowing the board to buy back the group's own shares, up to a maximum of 10 percent of the B shares outstanding, reference is made to the board's reasoned statement in accordance with Chapter 18 § 4 of the Swedish Companies Act submitted in connection with the proposed dividend of SEK 6.50 per share.
